The community lawn program under the Facilities department can assist Winnebago Tribal Members who are unable to mow their lawns and are willing to pay for services.

I also accept that my request may take time to be fulfilled. I will not complain or harass the facilities department staff at any time. By signing below, I understand that this privilege may be taken away if I do not follow the agreement, guidelines, and requirements.

Guidelines;

1. Must be 64 years and under.
2. Must sign a liability waiver. (Attached with the application)
3. Must prepay with a money order or debit/credit card down at the Finance office prior to mowing.
4. Physical address must be in Winnebago Nebraska.

Requirements:

1. Lawn must be totally free of debris. Facilities staff will not pick up debris.
2. Animals must be inside or off the area to be mowed.
3. Lawn must be accessible at the time of mowing.
4. Must understand this is a third priority to the program, we will not accept complaints, demands, harassments or other issues that may arise.
5. Release the Winnebago Tribe of Nebraska and the Facilities Department for any damages.

Community Lawn Mowing

The Community Lawn Mowing Program will be assisting Winnebago Tribal Members who are unable to mow their lawns and willing to pay for services.

Eligibility Guidelines:

1. Must be the age of 64 and under.
2. Provide proof of ownership or rental agreement.
3. Must sign liability waiver (program will provide).
4. Must pay with money order/card prior to program mowing the owners' lawn.
5. Physical Address must be in Winnebago, Nebraska.

Applicant Requirements

1. Lawn must be pick up from trash/debris and all objects removed.
2. Animals must be inside or off the area to be mowed.
3. Lawn must be accessible at time of mowing.
4. Must understand this is a third priority to the program, and subject to staff availability. We will direct all complaints to the Facilities Manager. Director(s) will be contacted if an incident occurs.
5. Must respond to applicant within 48 hours for scheduling mowing services.

Assistance Includes:

1. Mowing Lawn.
2. Weed eating

Pricing:

1. Extra Small residential — .50 acres or below \$20.00
 2. Small Residential - .51 — 1 acres \$30.00
 3. Medium residential — 1.1 — 2 acres \$40.00
 4. Large Residential — 2 — 3 acres \$50.00
 5. Extra Large residential 3 — 4 acres \$60.00
- **Two employees will be at the residence if more than 2 acres need to be mowed.

WAIVER: A waiver is required to be filled out by the homeowner, releasing the Winnebago Tribe of Nebraska, from liability. This waiver will be good for one mowing season, April through October of the current year.

Must pay mowing fee at the Finance Department and fill out waiver at the Facilities Department prior to mowing.
