2021 A2 & A3 ARCHERY DEER SEASON PERMIT APPLICATION

APPLICATION INFORMATION

- Applications will be accepted as soon as they are available.
- You must use an official 2021 Archery Deer Season Permit application form. Previous year's application forms will not be considered.
- All information must indicate preference: 1st choice, 2nd choice, and 3rd choice.
- Priority will be given to those with past season attendance, past quality harvest selection and past regulation compliance.
- Application deadline is October 1st 2021.
- Applications are accepted at a first come first serve basis.

Permit Information

- 1 permit per person. Permit includes 1 buck tag and 1 doe tag.
- Permit is good for hunting in Zone 1 and Zone 2.
- Deer hunts are self-guided (see attached map).
- Size regulations are 15" or above spread, 40" or above girth weight.

Archery season dates

- **1st Season** – August 28th – September 26th
- **2nd Season** – October 2nd – October 31st
- **3rd Season** – November 1st – November 16th
- **4th Season** – November 17 – November 30th

Classification

- Please self-validate your personal status in one of the following categories:
- A2 – Non-member
- A3 – Member of another federally recognized Native American tribe

PRICES/FEEES

- **Application fee** - \$25.00
***include with application.** Do not send permit and habitat stamp fees until you have received confirmation that you have been approved to hunt.
- **Permit (fees) –**
 - 1st Season** - \$800.00
 - 2nd Season** - \$1200.00
 - 3rd Season** - \$1400.00
 - 4th Season** - \$1400.00
- **Habitat stamp fee** - \$20.00
**2021 Winnebago Wildlife & Parks Habitat Stamp fee is required for all deer, turkey, small game and upland bird permits. Only one Habitat Stamp is necessary for all hunting during the 2021 season.*
- **Payment must be in the form of a money order or certified check. We do not accept cash or personal checks.**
